# Acceptance of Terms

When you place an order on the Cleanway Byotech Ltd (CBL) Web site, www.cleanwaybyotech.co.uk, you are agreeing to our Terms and Conditions

#### Ordering

Once you place your order online we will send you an email to confirm that we have received it. This email confirmation will be produced automatically so that you have confirmation of your order details. The fact that you receive an automatic confirmation

does not necessarily mean that we will be able to meet your order. We try to keep the CBL web site as up to date as possible but cannot guarantee that products will always be available. If we cannot supply a product you will not be charged for it and we

will refund or re-credit your account with the amount debited by us.

CBL may cancel any sale and not supply products if it is reasonable to do so and may change or discontinue the availability of products at any time at its sole discretion. If an order is cancelled, any payment made for the products will be refunded in full.

#### Price

The price for each product is shown on the CBL Web site and excludes VAT. Sales made to non EU countries is the price shown, and does not include VAT. Non-EU customers are responsible for Import Duty/Tax in their respective countries. Delivery

costs may vary depending on Location and our standard charge may not cover Ireland, North Scotland and outreaching locations. Unfortunately we cannot advise you what these costs will be - please consult your local customs office for more information.
